Overview

The scope of this document is to provide the release notes of Platform Data Extension API, with respect to a particular release version. It also includes the issues reported, open and solved within this release.

Known Issues

- No known issues.

Added Functionality

The highlights of this release are the following:

- Added new layer "Census Boundaries" for a growing set of countries. Please note that this layer is delivered as a separate map, it is not included in the map regions such as NA, WEU, EEU. Also, each country is represented as a separate layer, because each country's census data have a proprietary set of administrative levels and census attributes.
- Added new resource `tiles.json/tiles.txt`. Currently, the resource specifies the maximum number of tiles to request in a `singletiles.json/tiles.txt` HTTP request and the maximum number of key values to request in a single `index.json/index.txt` HTTP request. This might be subject to change in the future.
- Added new resource `serviceconfiguration.json/serviceconfiguration.txt`. It returns important limits that might change, currently the maximum number of tiles to request in a `singletiles.json/tiles.txt` HTTP request and the maximum number of key values to request in a single `index.json/index.txt` HTTP request.
- Added new parameter `meta=1` for `tile(s).json/tile(s).txt` to get the information about the tile - `layer`, `tilex`, `tiley`, `level`, `region` and `release`.
- Documentation resources like `layers.json` can now also be used without the parameters `region` and `release`, specifying the definitions for all regions and/or the latest available release respectively.
